- Limit of two items per maker, please.
- Categories are <u>Open</u> Bits, Spurs, Saddles, Leather Work, Engraving, Western Art, Etc.
- Open to any items, as long as made by the member maker to encourage creativity.
- Items will be For Sale Maker determines pricing (first price and best price)
- 10% of proceeds will go to the NBSSCA (2.75% also added in the event of credit card sale.)
- Open to all members of the NBSSCA; new members encouraged to join!
- Signed agreement must be in place before show opening.
- Makers encouraged to be in attendance at the show & also encouraged to participate in Brian Lebel's show. They do allow sharing of tables by up to two makers. This is the very best way for you to meet with prospective clients and show your work. You can download the vendor form at <u>www.oldwestevents.com</u>
- Items that are in need of stand or special display need to be provided by the maker and will be sold with the item. Price your product accordingly.
- In the event that an item does not sell, it will be returned to the maker.
- Items will be promoted with placards of each maker (photo, name, city, state, add'l info about the product as supplied by the maker). Additionally, the sale price will also be shown in a placard with the 'best' price kept private. (Best Price policy in place only if seller wishes.)
- Responsibility of the maker to deliver the goods to the show on June 9 OR to a NBSSCA representative, no later than June 1, 2017. In the event that a maker is not able to attend, a prepaid return label OR check in the amount of return postage must be

included. In the event the item is sold, the return mailing check will be returned to the maker.
